CLARIFICATORY ORDER

Dated: September 26, 2007

The Commission passed an Order dated April 3, 2007 (Case No. 66 of 2006) in the matter of Determination of Annual Revenue Requirement and Tariff for FY 2007-08 under MYT for BEST Undertaking. Subsequently, on September 7, 2007, the Commission issued a Clarificatory Order for BEST in the context of applicability of LT IV tariff (Advertisements and Hoardings).

The Commission, vide its Clarificatory Order dated August 24, 2007 (Case No. 26 of 2007 and 65 of 2006), clarified the applicability of tariff for HT temporary consumers in case of MSEDCL. Accordingly, the Commission is issuing the clarification for BEST in the matter of applicability of tariffs for HT temporary consumers.

The ninth paragraph of the approved Tariff Schedule placed in Annexure IV [Page No. 100] of the MYT Order for BEST stipulates the applicability of LT IX tariff as follows:

“LT IX: Temporary Supply

Applicability

Electricity used at Low / Medium Voltage on a temporary basis of supply for any construction work, decorative lighting for exhibitions, circus, film shooting, marriages, etc. and any activity not covered under tariff LT XI”.

Further, the eleventh paragraph of the approved Tariff Schedule placed in Annexure IV [Page No. 101] of the MYT Order for BEST stipulates the applicability of LT XI tariff as follows:

“LT XI: Temporary Supply for Public Religious Functions

Applicability

Electricity supplied at low / medium voltage for temporary purposes during public religious functions like Ganesh Utsav, Navaratri, Eid, Mohurram, Ram Lila, Ambedkar Jayanti, Christmas, Guru Nanak Jayanti, etc. or area where community prayers are held.

For the purpose of applicability of tariff for HT temporary consumers, it is clarified that the tariff applicable for LT IX category and LT XI category will be applicable also in the event of extending supply to consumers availing temporary supply at HT voltages, as per the nature of use of HT supply.

The clarifications given in this Order will come into effect from April 1, 2007.
