**NOTICE UNDER CLAUSE (a) OF SUB-SECTION (5) OF SECTION 15 OF
THE ELECTRICITY ACT, 2003 (EA 2003)**

1. An application for grant of Transmission Licence has been made by M/s Maharashtra State Eastern Grid Power Transmission Company Ltd (MEGPTCL), (Joint Venture of Adani Enterprises Ltd and MSETCL) "Adani House", Near Mithakhali Six Roads, Navrangpura, Ahmedabad – 380009, Gujarat.
2. A copy of the application alongwith its annexures and enclosures, made by Maharashtra Eastern Grid Power Transmission Company Ltd before the Commission can be accessed at the MERC website www.mercindia.org.in or inspected by any person in the Commission's office in accordance with the laid down procedure.
3. On consideration of the material available on record, the Commission is satisfied that prima facie the applicant qualifies for grant of Transmission licensee for development and operation of 765 kV Intrastate transmission System Comprising of 2 x 765 kV S/C Tiroda (Gondia) – Koradi Akola – Aurangabad transmission Lines along with associated substations & bays for evacuation of power from projects in North –Eastern Maharashtra. Applicant proposes to grant the licensee to, as a Transmission Licensee, as per Maharashtra Electricity Regulatory Commission (Transmission Licence Conditions) Regulations, 2004 and as amended by Maharashtra Electricity Regulatory Commission (Transmission Licence Conditions) Regulations, 2006.
4. Notice is hereby given in pursuance of clause (a) of sub-section (5) of Section 15 of the EA 2003 to invite the suggestions and objections, if any, to the proposal to grant Transmission licence to the applicant by the Commission, to be received by the undersigned **latest by August 13, 2010** at the above noted address. The objections or suggestions received after the specified date shall not be considered.
5. Every person who intends to file objections and comments/suggestions can submit the same in English and Marathi, in six copies, and should carry the full name, postal address and e-mail address, if any, of the sender. It should be indicated whether the objection is being filed on behalf of any organization or category of consumers. It should also be mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public hearing to be held on, -- **August 17, 2010 at 11.00 a.m. in the office of the Commission at 13th Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005.** No separate notice will be issued for the same.
