NOTIFICATION

Providing authority to disconnect supply line of electricity in accordance with the first proviso to Section 135 (1A) of the Electricity Act, 2003

Date: 26 March 2019

1. In exercise of the powers conferred under the first Proviso of sub-section (1A) of Section 135 of the Electricity Act, 2003 as inserted by the Electricity (Amendment) Act, 2007 and based on the submissions of the Distribution Licensees, the Maharashtra Electricity Regulatory Commission hereby authorizes the following officers of the Distribution Licensees and Distribution Franchisee mentioned in column (3) thereof, to exercise the powers under the first proviso of sub section (1A) of said Section 135 to disconnect the supply line of electricity, within the respective area of supply of electricity; in respect of the category of electricity consumers specified in column (4) of the table below:
