PUBLIC NOTICE

Inviting comments on draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution Licence applicable to M/s. Gigaplex Estate Pvt. Ltd. for IT & ITES SEZ at Airoli Knowledge Park, TTC Industrial Area, Airoli, Distt. Thane) (Second Amendment) Regulations, 2018.

M/s. Gigaplex Estate Pvt. Ltd. (GEPL) is a Developer for the notified Special Economic Zone (SEZ) area of 12.91 hectares at Plot No. IT-5, Airoli Knowledge Park, TTC Industrial Area, Airoli, Distt. Thane and, in accordance with Section 14 of the Electricity Act, 2003, it is a deemed Distribution Licensee to operate and maintain a distribution system for supplying electricity to consumers in that area. The Maharashtra Electricity Regulatory Commission (MERC) has notified the MERC (Specific Conditions of Distribution Licence applicable to M/s. Gigaplex Estate Pvt. Ltd. for IT & ITES SEZ at Airoli Knowledge Park, TTC Industrial Area, Airoli, Distt. Thane) Regulations, 2015 ('the principal Regulations') on 23 December, 2015 which has been subsequently amended on 3 February, 2017.

Pursuant to the Notification dated 30 October, 2017 issued by the Ministry of Commerce and Industry (Department of Commerce), Government of India, the Licence area of GEPL has been revised from 12.91 Hectares to 16.52 Hectares due to the addition of an area of 3.61 Hectares at Survey No. 145 (PT), 146 (PT), 147 (PT) 148 (PT), 149(PT) and 153 (PT) of Airoli Village. The Commission, vide Order dated 10 June, 2018, has allowed the change in the area of supply in principle.

The Commission accordingly proposes to amend the principal Regulations to the extent of the change in the area of supply.
