Inviting comments on draft Maharashtra Electricity Regulatory Commission (Specific Conditions of Distribution Licence applicable to M/s. KRC Infrastructure and Projects Pvt. Ltd. for IT & ITES SEZ at Village Kharadi, Taluka Haveli, District Pune) Regulations, 2018

M/s. KRC Infrastructure and Projects Pvt. Ltd. has been notified as "Developer" by Ministry of Commerce & Industry, Government of India under Special Economic Zones Act, 2005, for Special Economic Zone located at Survey Nos. 65 (1), 65(2) and 65(3), Village Kharadi, Taluka Haveli, District Pune.

In accordance with section 14 (b) of Electricity Act, 2003 (EA, 2003) read with sub-section (1) of section 4 of Special Economic Zones Act, 2005 (SEZ Act), M/s. KRC Infrastructure and Projects Pvt. Ltd. is a deemed distribution licensee to operate and maintain a distribution system for supplying electricity to the consumers in aforesaid SEZ area as specified in the SEZ notification of Government of India. The Commission vide Order dated 25 June, 2018 in Case No. 75 of 2018 has confirmed the deemed distribution licensee status of M/s. KRC Infrastructure and Projects Pvt. Ltd.
