has been changed to M/s. Mindspace Business Parks Pvt, Ltd.

and a fresh Certificate of Incorporation has been issued by the Registrar of Companies accordingly. The Commission, vide Order dated 16 May, 2016, has allowed the change in name in principle. The Commission accordingly proposes to amend the MERC (Specific Conditions of Distribution Licence applicable to M/s.

Airoli, Thane) Regulations, 2013 to the extent of the change of
