PUBLIC NOTICE

Inviting Comments on Application of M/s. Global Energy Pvt. Ltd. for grant of Trading Licence under Section 15 of the Electricity Act, 2003

1. M/s. Global Energy Pvt. Ltd. (GEPL) has made an Application under Section 15 of the Electricity Act, 2003, before the Maharashtra Electricity Regulatory Commission (the Commission) for grant of Category 'A' Licence for Intra-State Trading within Maharashtra.
2. GEPL had published a Notice in (i) The Free Press Journal (English), (ii) Sakal Times (English) (iii) Pudhari (Marathi) and (iv) Navashakti (Marathi) on 14 July, 2017, as required under Section 15(2) of the Act inviting written suggestions or objections, but none has been received.
3. The Commission is prima facie satisfied that, GEPL qualifies for the grant of Licence for Intra-State Trading of electricity to the extent of 50.02 MUs in the first year increasing to 73.18 MUs over a period of five years. The Commission proposes to grant the Licence to GEPL as a category 'A' electricity trader in terms of MERC (Trading Licence Conditions) Regulations, 2004 as amended till now, subject to fulfillment of the requirements laid down in the Electricity Act, 2003 and Regulations.
4. A copy of GEPL's Application along with its Annexures and enclosures can be accessed at the Commission's websites www.merc.gov.in / www.mercindia.org.in or inspected in the Commission's office.
5. Comments, suggestions or objections on the proposed grant of Trading Licence may be filed in English or Marathi, in (6+1) copies, which should carry the full name, postal address and e-mail address, if any, of the sender and addressed to the Secretary of the Commission, personally or by post; or by Fax or e-mail [Fax: 22163976; E-mail – mercindia@merc.gov.in] within thirty days from the date of publication of this Notice. It should be indicated whether the responses are being filed on behalf of any organisation or of any category of consumers. It should also be mentioned if the sender wants to be heard in person, in which case opportunity would be given by the Commission at the Public Hearing to be held on **4 October, 2017 at 12:00 hrs at the Centrum Hall, 1st Floor, Centre No.1, World Trade Centre, Cuffe Parade, Mumbai 400 005**, when GEPL's Application for grant of Trading Licence will be considered. No separate notice will be issued for the purpose.
